

Artist Application and Agreement Form Barnstormers Tour and Plein Air Paint Out

Thank you for using your talents to help call attention to our endangered barns!

(Please read carefully, check boxes to acknowledge understanding, then sign, date and return the completed form. Applicants must be at least 18 years of age.)

I understand that there is a Non-Refundable \$35 Artist Application Fee. Please make your check payable to FCLF (Frederick County Landmarks Foundation) and mail to the address below. Based on postmark date, the first 32 artists whose completed applications are received will be able to participate in the plein air paint out and to display/sell work completed that day during the afternoon art show/sale. A waiting list for cancellations will be compiled.

I understand 30% of the Sales Price will be collected to benefit FCLF historic preservation work. A 6% sales tax must be added to the Sales Price.

I understand that I am responsible for providing my own framing and ready-to-hang supplies and free standing tripod easels for the art show to display each of my artworks. I may display/sell only artworks produced during the event. However, only one work may be entered for judging. An area will be provided to complete framing.

I understand the plein air paint out, art show, and sale will take place outdoors rain or shine, and I am responsible for providing my own weather provisions. A covered area will be provided by Frederick County Landmarks Foundation to provide protection for art during the show and sale in case of inclement weather.

I understand that my sold artwork is held for display until the event closes at 5 PM and that I am responsible for picking up any unsold artwork at 5 PM as well. FCLF cannot be responsible for work left behind.

I understand that I am participating in this event at my own risk. The FCLF and Barn Owners will not be responsible for any injury or damage that may occur during this event.

I understand that barn environments are not inherently handicapped accessible and as a participating artist, I must advise FCLF, at the time of application, of any special needs for coordination of accommodations as circumstances best allow.

I understand photos will be taken of my artwork and I give permission to FCLF to use them in both their print and electronic publications; including but not limited to newspapers, rack cards, ticket booklets, archival storage and on the Foundation's Website and Facebook pages.
